Support Inter Pares through Donations of Stocks and SECURITIES

Thank you for requesting information on how to make a donation of stocks or securities to Inter Pares. Donating publicly traded securities is a popular type of gift for some donors. Donating publicly listed securities, such as stocks, bonds, or mutual funds to Inter Pares is a way of investing in social justice in Canada and overseas.

THE IMPACT OF YOUR DONATION — AN EXAMPLE

For over two decades, Inter Pares has worked with local organizations in Guatemala to provide psychological and social support to survivors of the civil war. In May 2013, a trial found former Guatemalan dictator Efraín Ríos Montt guilty of having committed genocide and crimes against humanity against the Maya Ixil people. The trial established an international precedent, as it was the first time a former head of state faced such charges in his or her own country. The outcome was in large part due to the steadfast courage of

Maya Ixil survivors, who testified in the trial with the accompaniment of our counterparts.

TAX ADVANTAGES OF DONATING STOCKS AND SECURITIES

There are significant tax advantages in donating your stocks or securities directly to a charity like Inter Pares, rather than selling the shares and donating the proceeds. Since capital gains tax is not applicable on gifts of securities donated to Canadian charities, you will receive a tax receipt for the value of the gift, and you will not have to pay tax on any related capital gains.

HOW TO MAKE GIFTS OF STOCKS AND SECURITIES

STEP ONE: CONSULT YOUR ADVISOR

If you are considering a gift of securities to Inter Pares, we recommend that you consult your financial advisor before proceeding with the gift.

STEP TWO: ARRANGE TRANSFER

If your securities are held in a brokerage account, please contact your broker to arrange for the transfer to Inter Pares' account with RBC Dominion Securities. Your broker will ask you to sign an authorization to transfer securities, and the securities you are donating will be electronically transferred to Inter Pares' account.

STEP THREE: FINALIZE TRANSFER

Once you have made arrangements to transfer the securities to Inter Pares, please contact Jack Hui Litster at jack@interpares.ca or 1-866-563-4801 to provide us with your contact information, along with the type of security and number of units that you are donating. This information enables Inter Pares to monitor the transaction and issue a tax receipt. Once the transfer is complete, a charitable tax receipt will be issued to you based on the securities' full market value at the close of that day.
